MINUTES OF THE DECEMBER 5, 2011
BOARD OF TRUSTEES MEETING
NEVADA STATE RAILROAD MUSEUM
CARSON CITY, NEVADA

Call to Order – The meeting was called to order at 6:00 PM.

Role Call – Present were Ron Allen, Darlene Berry, Bruce Armbrust, Ralph Elligott, Chris MacMahon, Kurt Dietrich, Frank Ackerman, and Matt Digangi. Absent and excused was Stan Cronwall and David Brambley. A quorum was established.

Minutes – Kurt Dietrich presented the October 2011 minutes. A motion was made by Bruce Armbrust, seconded by Matt Digangi, to accept the minutes as corrected. Motion passed.

Brick Sales Committee – Laning Clifford reported that one brick has been sold during the past two months.

Election Committee – Nancy Humphries asked Kurt Dietrich to provide her the tally sheet for the 2011 election.

Fund Raising Committee – Bill Kohler stated that if all of the cachets are sold, the Friends should expect a \$900 net profit. Ron Allen stated that the cachet information should be placed on the website and Facebook.

Interpretive Committee – Loren Jahn stated that there should be a walkthrough exhibit in the depot for the Santa Train events. Loren stated that Allied Washoe donated \$100 in coal for the event.
